

Chapter 1. IBM Flex System CN4052 2-port and CN4058S 8-port 10Gb Virtual Fabric Adapters

The IBM Flex System $^{\text{TM}}$ CN4052 2-port and CN4058S 8-port 10Gb Virtual Fabric Adapters are converged network adapters (CNAs) that are designed for use in IBM X-Architecture $^{\text{®}}$ compute nodes.

This *User's Guide* contains information and instructions for installing the adapters, updating the firmware, and solving problems. See the documentation that came with your IBM Flex System compute node for information on how to physically install the adapters. Return to this *User's Guide* for information and instructions needed to complete the functional installation.

Features and specifications

The IBM Flex System CN4052 2-port and CN4058S 8-port 10Gb Virtual Fabric Adapters have the following features and specifications:

- The eight-port 10GB Virtual Fabric adapter with two operational mode choices:
 - o Eight-port Physical Mode, pNIC, Mutichannel disabled, or
 - The default Virtual NIC Mode, vNIC, Multichannel enabled; vNIC mode provides four vNICs per physical port for a total of 32 vNICs.
- The two-port 10GB Virtual Fabric adapter with two operational mode choices:
 - Two-port Physical Mode, pNIC, Mutichannel disabled, or
 - The default Virtual NIC Mode, vNIC, Multichannel enabled; vNIC mode provides eight vNICs per physical port for a total of 16 vNICs.
- Establishing active links in vNIC mode requires some configuration on the connecting I/O modules. Until configured, the vNIC links will be in a Link Down state.
- The adapter supports three options for vNIC linking:
 - o VNIC1, IBM Virtual Fabric Mode, which is the default option.
 - VNIC2, Switch Independent Mode, which can be selected in Setup. Each 10Gb physical port supports either four vNIC devices (IBM Flex System CN4058S 8-port 10Gb Virtual Fabric Adapter) or eight vNIC devices (IBM Flex System CN4052 2-port 10Gb Virtual Fabric Adapter).
 - o Unified Fabric Protocol Mode, which can be selected in Setup.
- The following is a list of the features the adapter supports.
 - Link Auto negotiation 10 Gb/1 Gb Full duplex
 - Agentless hardware management support
 - Virtual Ethernet Bridging (VEB)
 - Quantized Congestion Notification (QCN) part of Data Center Bridging (DCB) standards. QCN provides end-to-end congestion notification for Layer 2 networks. QCN is defined in the IEEE 802.1Qau standard.
 - IBM Distributed Overlay Virtual Ethernet (DOVE) Offload support. DOVE allows an abstraction of the physical network infrastructure from hypervisor hosts. It allows network changes to be made in software.
 - Physical ports
 - Eight 10Gb ports each supporting one FCoE or iSCSI device and up to four vNIC devices (IBM Flex System CN4058S 8-port 10Gb Virtual Fabric Adapter)
 - Two 10Gb ports each supporting one FCoE or iSCSI device and up to eight vNIC devices (IBM Flex System CN4052 2-port 10Gb Virtual Fabric Adapter)
 - Low latency RoCE protocol support (only on Windows systems)
 - Bus-mastering support
 - o Direct memory access (DMA) support

- Uses standard Emulex® SLI drivers
- Interoperates with existing FC SAN infrastructures switches, arrays, SRM tools (including Emulex utilities), SAN practices, and so forth
- o Unified Ethernet-to-FC SAN connectivity provided by an FCoE switch
- Provides 10 Gb MAC features such as MSI-X support, jumbo frames (9k bytes) support, VLAN tagging (802.1Q, PER priority pause/priority flow control), and advanced packet filtering
- No host operating system changes are required. NIC and adapter functionality (including device management, utilities, and so forth) are transparent to the host operating system.

- o Integrated Open Fabric Manager (IOFM) support
- Preboot Execution Environment, UEFI and Legacy PXE

- The IBM Flex System CN4058S 8-port 10Gb Virtual Fabric Adapter is constructed with two four-port NICs, Network Interface Controllers, or ASICs. The four ports of each ASIC connect in parallel to one I/O Module bay, one ASIC to I/O bay 1 and the other ASIC to I/O bay 2.
 - o If the adapter is installed in I/O expansion connector 1 of the compute node, the I/O bays are 1 and 2.
 - o If the adapter is installed in the I/O expansion connector of the compute node, the I/O bays are 3 and 4.
 - The adapter is manufactured with 32 burned in MAC addresses.
- The IBM Flex System CN4052 2-port 10Gb Virtual Fabric Adapter is constructed with a single two-port NIC. The adapter is manufactured with 16 burned in MAC addresses.
- If an adapter is in pNIC mode without storage configured, each port uses two MAC addresses. One MAC address is used for normal Ethernet traffic, while a second MAC address is used for LLDP traffic. If the adapter is put into vNIC mode, or if storage is enabled, then more than two MAC addresses will be used on each port.
- When enabled via FoD, the iSCSI or FCoE operations are supported on the second vNIC of each physical port, or in Physical pNIC mode the functions are across all eight ports.

- Separate NIC, iSCSI, and FCoE drivers are provided to support all configurations.
- A full complement of Emulex OneCommand™ Manager tools and applications are available to support the operation of this adapter.

Running POST

To ensure that they are fully operational, the adapters process a series of tests during power-up or a restart (power-on self-test, or POST). These tests take approximately one minute to complete. The management module reads the test results and displays them for you. During normal operation, these tests are completed without error. However, if an adapter fails POST, the system-error LED on the chassis is lit.

Parts listing

Replaceable components are of three types:

- **Tier 1 customer replaceable unit (CRU)**: Replacement of Tier 1 CRUs is your responsibility. If IBM installs a Tier 1 CRU at your request, you will be charged for the installation.
- Tier 2 customer replaceable unit (CRU): You may install a Tier 2 CRU yourself or request IBM to install it, at no additional charge, under the type of warranty service that is designated for your server.
- **Field replaceable unit (FRU)**: FRUs must be installed only by trained service technicians.
