Chapter 1. IBM Flex System EN2024 4-port 1Gb Ethernet Adapter

The IBM® Flex System EN2024 is a quad-port network adapter that provides 1 Gb per second, full duplex, Ethernet links between a compute node and Ethernet switch modules installed in the IBM Flex System chassis. The adapter interfaces to the compute node using the Peripheral Component Interconnect Express (PCIe) bus.

Note: The IBM Flex System EN2024 4-port 1Gb Ethernet Adapter is referred to throughout this document as the adapter.
